

PRIVACY INFORMATION NOTICE

pursuant to Articles 13 and 14 of the Regulation (EU) 2016/679

Data Controllers

MSC Foundation, headquartered in Geneva, Switzerland, and *Elbe Habitat Foundation*, headquartered in Hamburg, Germany, act as Joint Controllers in collecting and processing personal data about the visitors of the website <https://elbehabitatcharitygala.mscfoundation.org/en>. The personal data processing is carried out in accordance with the principles of the Regulation (EU) 2016/679 (the General Data Protection Regulation, hereafter "GDPR").

Categories and Purposes of Data Processing

The Data Controllers process personal data within this website to inform the public about the Elbe Habitat Charity Gala (the "Gala"), to sell tickets for the Gala and to collect donations from the public.

Ticket sales are processed by *Elbphilharmonie und Laeishalle Betriebsgesellschaft mbH*, in accordance with its [Privacy Policy](#). The name and surname of the ticket holder are processed for the purposes of completing the transaction.

Donations are processed by *PayPal*, in accordance with its [Privacy Policy](#). Information about donations is made available to *MSC Foundation* and *Elbe Habitat Foundation*, who use it only in connection with the Gala, to identify and thank the donors. If you wish to make an anonymous donation, please contact info@mscfoundation.org.

Personal data is used only for the purposes specified above, to enable guests to purchase tickets and make donations. The data will not be used for marketing purposes, unless the appropriate consent is given by the guest.

Data Retention

In accordance with Article 5.1(e) GDPR, the personal data that we collect is kept in a form which permits the identification of data subjects for no longer than is necessary for the purposes for which the personal data are collected and processed in each specific case, and in any case not longer than as specified by the relevant applicable laws.

Your Privacy Rights

In accordance with articles 15-22 of the GDPR, you have the right to:

- Obtain access to your personal data;
- Request the rectification or deletion of personal data or the restriction of data processing;
- Oppose the treatment of personal data;
- Receive your personal data in a structured format of common use and readable by an automatic device;
- File a complaint with the relevant data protection authority (taking into account the place of residence of the data subject or the place of supplying of the services), in accordance with article 77 of GDPR, if you believe that the processing of personal data is in violation of the GDPR.

Notwithstanding your right to oppose the processing of some or all of your personal data, the Data Controllers reserve the right to evaluate the request, which will not be accepted in case the legitimate reasons of the Data Controllers prevail over the rights and interests of the data subject.
